Dear Kimberly French and members of the CPC Board,

On behalf of the Board of Nemasket Hill Cemetery Association Board, I wish to express our sincere gratitude in allowing us additional time to submit Step 2 of the grant.

The issue we encountered was having contractors submit estimates: on seven occasions we experienced no-shows, after viewing the project and seemingly interested, five contractors- offered no estimates (even after numerous attempts to contact them), and a contractor even wanted hundreds of dollars of nonrefundable money for an estimate. It has been quite an interesting journey.

Our focus has always been on the restoration of the interior of the building. After consulting with several masons, we realized a shift was needed to additionally focus on the *preservation* of the exterior of the building. The masons do not feel the exterior of the building is in serious decline, quite the contrary. These are measures to ensure the integrity of the building for many years to come. This entails: cleaning the exterior concrete (blocks and grout), re-pointing, and applying a clear coat of sealant to protect it from the environment. It also includes filling in the hollow columns on the porch to give additional strength to continue to hold up the porch roof. There would be recasting of a broken side support on the porch, as well. Continuing on with preservation, the masons felt the nonstructural crack on the interior (opposite the chimney) would best be repaired to extend support to the chimney by placing re-bar and re-stuccoing that wall.

One final preservation item would be to address the moisture in the basement that is caused by exterior moisture. Along the exterior wall would be dug out, placing a sealant on the below grade area, a French drain installed, rocks filling the ditch and regrading the ground. In addition facia boards and gutters will be installed in an effort to keep moisture away from the foundation.

The additional preservation will be adding to the overall grant needed. The Board feels we would be remiss if we did not address these areas in preserving the building, at this time.

Since we are asking for 100% assistance, the Board was unsure if this request should be over a 2 year time-frame, to allow for your budgeting. We have been assured that all interior and exterior work could be completed before winter 2021.

Please note, to date, we were unable to locate a tin ceiling restoration specialist. We priced replacement of the tin ceiling. Rest assured, the original ceiling will be re-purposed in the interior. (Here are some of our thoughts: surround the electric fireplace, encase a podium, and use as the back wall of shelving, etc.-trustees would be doing this work)

It was determined the original pine flooring would disintegrate if sanded. We obtained a flooring estimate of unstained red oak. (Once taken up, we hope to re-purpose any of the flooring that is salvageable to perhaps frame pictures and use as shelving-trustees would be doing this work.)

We hope when you see the volunteer hours put forth by trustees (*see attachment 43*) that you will realize that the trustees have been dedicated and diligently caring for Nemasket Hill Cemetery since the superintendent retired 7 years ago. We hope you will assist us in restoring, rehabbing and preserving this historic 110 year old building.

Brief Project Description: The building/chapel was constructed in 1911. The building would serve well for anyone wishing a small venue. It is our plan to rehab the building to be used as a meeting, gathering and/or service area.

The original building had a holding tomb in the basement(which is still quite visible) that was used to store deceased in the winter. Surrounding towns rented out space for their deceased to be held through the winter.

The goals of the CPA include to rehabilitate, restore, and preserve historic resources, which is what we hope to accomplish for the building with the assistance and approval of this funding.

B: PROJECT NARRATIVE

1. Goals and Description:

- a. The primary goal for the building/chapel project is to restore and preserve the Nemasket Hill Cemetery building/chapel, which was constructed in 1911. The original funds for the building were obtained from the group whose name changed over a period of years: initially known as the Warrenton Serving Circle, the group was also known as Nemasket Cemetery Improvement Society and Nemasket Cemetery Circle, also a tea party hosted by Count Magri and subscriptions from town residents.
- b. A previous project to preserve the chapel/building was to replace the asphalt roof with a metal roof. (The decision for metal vs asphalt was due to research indicating that asphalt was not used until the end of the 1920's. With no existing pictures of the building, the roof would have been slate or metal. The Board decided on a slate-looking metal.) This required replacement of sheathing and sistering rafters. The metal roof came with a 100 year warranty. The chimney was capped due to extreme deterioration above the roofline, and since it would serve no function, it was deemed in the best interest of safety to cap it.
- c. This project is eligible for CPA funding per the Town of Middleborough Community Preservation Committee's Guidelines, specifically under preserving and rehabilitating/restoring the historic building. The project applicant is the Nemasket Hill Cemetery Association, whose existence dates back to 1885, when it was incorporated. The Trustees (as stated in their bylaws) are to act in the best interest of lot and niche owners and those interred at Nemasket Hill Cemetery. As Nemasket Hill Cemetery is a 50lcl3, it is unable to accept donations for specific items. It can only accept general upkeep donations. Due to this designation, Friends of Middleborough Cemeteries is partnering with Nemasket Hill Cemetery Association, so they may accept specific donations and disperse them for the preservation and maintenance of the cemetery's historical features. Also, due to this designation, Nemasket Hill Cemetery Association cannot apply for historic grants or be sponsored by a 501c3 nonprofit.

2. Community Need:

Community needs that this project will address include restoring and preserving an historic building associated with the oldest cemetery in Middleborough. This is consistent with the Middleborough Historic Preservation Plan as well as with the Community Preservation Plan which seeks to recognize, restore and preserve the history of Middleborough. By restoring and preserving the building, it will protect the contribution made by a group of residents in Middleborough's history, as it is threatened to further deteriorate and could potentially become irrecoverable if no action is taken. (pictures see attachments 2-4)

3. Community Support and Outreach (Please refer to attachments 5-9 for documents of support.)

4. Credentials

The project applicant is the Nemasket Hill Cemetery Association, whose members include Carol Damon (retired Middleboro teacher-35 years), Joan Gladu (Lakeville Cemetery Commission member), Kathleen Grace (retired registered nurse-42 years), Bob Soderbom (cardiac technician), Chuck Washbum (H&R Block agent), Margaret Washburn (retired Talbots bookkeeper) and Anne Williams (retired contractor).

The contractors who submitted estimates are specialists in their field

- 1-Floor Coverings International -second generation family owned and run business
- 2-Steri-Clean -primarily serves Rhode Island & Connecticut in areas of biohazard remediation
- 3-Gates Masonry & Construction -over 23 years experience in the ways of "old world mason craftsmanship". They specialize in many phases of construction, as well as historic preservation.
- 4-Gutter Cowboy-specializes in gutter installation, cleaning, rehab and gutter guards.

5. Maintenance and Ongoing Costs

With any historic building, there will be maintenance. To keep the building from deteriorating, the Association will add an addendum to the bylaws for a yearly inspection and money appropriated for any maintenance needed. All items being addressed through this rehab, restoration and preservation will be addressing areas of concern that could potentially cause the building to deteriorate. With this grant, it is quite hopeful that the building will last for many years to come.

Nemasket Hill Cemetery Association is a nonprofit whose purpose is to provide a "resting place" (burials) and to maintain the 33 plus acres of property it resides on. The cemetery is currently cared for by volunteers. Any money collected from lot and niche sales, interments, disinterments, foundations, grounds usage, and clerical fees are used for the upkeep of the cemetery. (Please refer to attachment 10 for the item price list. The Board maintained the same prices for over 5 years, but has found even with volunteers, we needed to raise them to deal with trees and other issues.)

It is the vision of the current Trustees to have funding available for future upkeep. The building will assist in the upkeep of the property as it will be rented for gatherings, meetings and/or services. As many funds as possible gained from "property" (ie.spaces, lots, niches) purchases are deposited into the Association savings account to prepare for future needs. All other funds collected go into the Association checking account for current expenses. Current expenses include, but are not limited to equipment, (lawn mowers, trimmers, weed whackers), gasoline for machinery operation, Bobcat, rental equipment, all equipment maintenance, resetting stones, repairing stones, cleaning stones, providing temporary markers on spaces/lots, grass seed, loam, crushed stone, gravel, tree maintenance, digitized record database (Pontem), genealogical research, security, rubbish disposal, and office supplies such as ink and paper for correspondences, genealogy, and contracts for payment plans.

6. Success Factors

The only barrier foreseen for successful completion of this project is financial. It is the Trustees hope that through the CPA grant that the building may be preserved and restored. The Board views the Community Preservation Committee as our only hope in getting the building restored, rehabbed and preserved for use by the public.

7. Project Permits & Approvals

a. Control of Site:

The Nemasket Hill Cemetery was purchased from the Indians. (*Please see attachment 11-12 for original recorded deed dated 1671.*) The cemetery was incorporated on March 24,1885. (*Please refer to attachment 13 for a copy of the incorporation record. Please also see attachment 14-15 for the current filed corporation sheet from the Secretary of State.*)

The cemetery is governed by a group of trustees, and anyone who purchases or inherits a space/niche becomes part of the Association.

In his book <u>History of the Town of Middleborough, Massachusetts</u>, in the chapter "Cemeteries", Thomas Weston wrote: "The Nemasket Hill Cemetery, beautifully situated on a high bank on the Nemasket River, is the oldest in town. It was set apart by the proprietors of the Twenty-six Men's Purchase in 1662, and was used by the early settlers as their only burial place for more than two generations formerly known as Burial Hill and simply The Hill. The oldest stone that may be located is that of Elizabeth Vaughan, who died June 21, 1693, aged sixty-two years. It was not until the later part of the seventeenth century that inscribed stones giving the name, birth, and death of the deceased were used to any great extent in any of the burial grounds of the Old Colony. The graves were usually marked, if marked at all, by ordinary stones set at the head and foot of the grave. Here most of the early settlers are buried, although the graves of John Tomson and Samuel Fuller are the only ones now known. It was incorporated by a special act of legislation March 24, 1885 as the Nemasket Hill Cemetery Association. At the time of the Twenty-six Men's Purchase, it was controlled by them, and after their descendants, who had the rights of burial until the time of its incorporation"

(Please refer to attachment 16-21 for cemetery by-laws.) (Please note Footnotes 4 and 5 in reference to the commitment of the Nemasket Hill Cemetery Association to maintain the arch and gates.)

b. Deed Restrictions:

(Refer above to 7a) The cemetery is land set aside to provide a "resting place" (burial). There are no deed restrictions for this project.

c. Hazardous Materials:

No documentation required for the building.

d. Environmental Concerns:

The proposed project has no environmental impact. (Please refer to attachment 22)

e. Evidence of Historical Significance: Please refer to attachment 23 for a letter from MHC.

f. Permitting:

According to the Building Commissioner per a phone message the only permit required for this project is electrical. It was filed in 2015.

In a site visit in 2017, the building commissioner outlined items needing attention: Update electrical, exit lights over each door, handicap access, handicap port-a-potty

All ADA's required will be addressed

C. PROJECT BUDGET, FUNDING & TIMELINE

1. Project Budget:

(See attachment 24-37 for estimates.) As noted the prices given are only guaranteed for 30 days. It may increase by the time this project moves forward. CPA funds would be needed for the entire scope of work.

2. Other Funding:

Although it is difficult to quantify the value the volunteers (which includes the Trustees) have brought to efforts in preserving the cemetery and its grounds, the cemetery has been able to reallocate funds once spent on the clerk and superintendent labor expenses and taxes (please refer to attachments 38-42 for itemized expenditures and income) to preserve and restore many needs at the cemetery that before were impossible. Please find the ways we have "saved" money by utilizing donated time and items in order to fund preservation and restoration at Nemasket Hill Cemetery. Volunteers (including Trustees) assist with landscaping including but not limited to trimming bushes, raking and picking up branches, and mowing the estimated 10 acres of cleared land with active, daily use. (see attachment 43 for the value of volunteer work for the last 7 years)

A-Electrical in the building/chapel structure began being replaced in 2015. The tube and wire needs to be completely replaced by up to code wiring by a licensed electrician. We paid labor expenses (\$2000) and the electrician donated materials (\$2000 value) on what was partially completed.

B-The Association paid for 3 Trustees to attend classes with Jon Appell from Gravestone Preservation to learn how to properly clean gravestones, reset at-risk gravestones and repair broken headstones. To date, Trustees have cleaned 106 Civil War headstones as well as countless other headstones. We have purchased the D-2 Environmentally safe cleaner to do this, along with equipment needed. According to one memorial company this would have cost \$100 per stone(if this service was contracted out) . We are training volunteers and providing the expensive cleaner D-2, plus materials for volunteers to use. Please refer to attachment 44 for an estimate from a local vendor(if this service was contracted out) .

C-One Trustee reset granite curbing around a family lot. According to one monument company, this would have been a cost of \$100 per foot. This would not have been able to be completed if not for his effort. Please refer to attachment 44 for an estimate from a local vendor (if this service was contracted out).

D-Trustees have used Jon Appell's strategies by creating a tripod to lift stones when resetting them. To date, over 45 head stones have been reset by Trustees and volunteers. With a cemetery of this age, many stones are at risk of falling, tilting due to roots and are getting buried by leaves year after year covering them. According to one memorial company each stone we lift, correctly align and reset would have been a cost of at least \$100.00(if this service was contracted out). Something we would never have been able to afford.(Please refer to attachment 44 for an estimate from a local vendor-if this service was contracted out).

J . . . - . .

E-After an anonymous accident bent the front gate, Bristol-Plymouth Regional Vocational School's Iron Works students removed, repaired and reset the gates only charging \$20.00 for paint. (We were told by an iron works specialist this would have cost in excess of \$3000.00.) Subsequently, we were able to obtain a CPA Grant to restore and preserve the arch and gates. As you may already be aware, the restored arch & gates were replaced for less than 10 days before sustaining extensive damage by a boom truck that backed into it twisting the arch, snapping the letters, embedding the gates into the ground causing creases and also dislodging the granite posts. After walking the street and interviewing many neighbors, we were able to discover the company responsible. NHCA was advised to contact Bartlett Associates who represented the cemetery (as there was no insurance on the arch & gates and granite posts).

F-When the caretaker/superintendent of many years retired, the Trustees took on the arduous task of maintenance, lot and niche sales, and preparation /closing of funerals. The Association found itself in a difficult financial situation with the economic climate as people were choosing cremation with no interment. A decision was made to put future niche and lot sales in savings to protect against future economic issues and to be able to acquire needed equipment and supplies, and also begin projects that had before been financially out of reach..

G-What price can you put on public relations. Trustees meet with prospective lot/niche owners (see attachment 43), attend ALL services (see attachment 43), create and maintain the website and Facebook page. On average a Trustee spends 20 hours a week on the computer answering emails, genealogy research, updating the database, and using Quikbooks. (see attachment 43)

H-When the winter storm Nemo struck Nemasket Hill Cemetery, it was fortunate no gravestones were damaged, but it did suffer a lot of tree damage. The outpouring of support from the Town of Middleborough was amazing. Two days of chainsaws and truckloads of branches to the dump saved the cemetery a lot of money that then allowed us the ability to hire a tree company to complete the rest. The cemetery again sustained extreme destruction when a microburst hit in August, 2020. Approximately 15 stones were knocked off their foundations. The volunteers that came brough trucks, splitters, chippers, cases of water, pizza and hard workers. Even with ALL the volunteers, the Association had to spend close to \$20,000 to address the trees in 2020.

I-Although we have been able to "save" funds in some areas, we have spent money on much neglected items: new equipment, new tires for the Bobcat, tree work, cleaning and correcting headstones and hiring specialized contractors when volunteers do not have the skill set to complete a project.

3. Total Project Funding:

Total project cost is estimated \$103,494.30. These quotes were only guaranteed for 30 days and may change once the project is approved. Please note this total may decrease if the tin ceiling is taken down, there will be no need for the \$7000 expense of cleaning, if the original electrician comes back, the \$13,800 will significantly drop (Scott Greenlaugh, the first electrician's wife has been suffering with COVID).

4. Timeline and Grant Disbursement Schedule:

Project Start Date will be established when funds are made available. The Contractors and the Association hope to complete this work by the end of 2021.

Dear Ms. Damon,

I want to tell you before the year runs out how amazed am I at the seemingly tireless devotion and energy that you and the other trustees and volunteers have for Nemasket Hill Cemetery (NHC). Yes, I know I volunteer there too but not often enough, and it pales in comparison to you all, but man-oh-man you continue to amaze me!

I know you are actively pursuing a restoration on the chapel there. What a great endeavor! I love it because the opportunities for its use can be far reaching. While it is early in the planning phase of what all it can become and perhaps, I am off-beat on some of my lofty ideas but I can see it as:

- A place for Friends of Middleboro Cemeteries to call home. A home for their meetings. A place
 for gravestone restoration seminars they want to hold. A place for them to store supplies,
 records, and exhibits. A win-win for them because they can store all their records and supplies in
 one place and save on storage fees elsewhere.
- A place for non-denominational gatherings for family and friends of someone being laid to rest at NHC.
- A place to exhibit pictures of historic Middleboro and its cemeteries. (I have some for you.)
- A place to learn about the family members interred at NHC and the history of the cemetery.
- A place to use the onsite collection of books to learn about Middleboro, its people, and its days past. (I have a collection for you.)

Why am I so enthused by the restoration of this building? My ancestors were among the first settlers of Middleboro in 1661. My great-great grandmother was a member of the sewing club that raised money for the beautification of the cemetery by adding the gateway and cemetery chapel, though I believe it might have been referred to as the cemetery office back then and not a chapel. Nemasket Hill Cemetery Association A Non-Profit Corporation

Article 1 History of the Association

The Nemasket Hill Cemetery Association was incorporated and recorded at the Register of Deeds Office for Plymouth County, Massachusetts. The Association was formed by a group of Middleborough, Massachusetts citizens for the purpose of holding land to be used exclusively as a cemetery.

Article 2 Purpose of the Association

The Nemasket Hill Cemetery Association (hereinafter the Association) is a 501(c)(13) in accordance with IRC(Internal Revenue Code). As such, the Association is a nonprofit (without profit to any officer, Trustee and/or Corporation). It is dedicated to the purpose of providing a dignified resting place for deceased persons. Lot/niche ownership and interment are open to anyone who abides by the Rules and Regulations, and the Bylaws of the Association.

Anyone who has inherited or purchased a burial space at Nemasket Hill Cemetery is a member of the Nemasket Hill Cemetery Association.

Article 3 Purpose of the Bylaws

These Bylaws are written by the Association to act as a guideline for the Board of Trustees and the membership, in general.

Article 4 Amendments to the Bylaws

As the needs of the Association change, these Bylaws can be changed or amended in order that the Association, through the Board of Trustees, may continue to perform its duties in an effective manner. The Annual Meeting or a Special Meeting, called for that purpose, shall be the time and place for amending the Bylaws.

Once adopted, by the Trustees, these Bylaws replace and supersede those Bylaws originally adopted in 1886.

Article 5 Board of Trustees

A trustee is one who holds a legal obligation to act in the best interest of another, in this case, the best interest of lot holders and those interred. The Trustee is typically a fiduciary, that is, someone entrusted with care of money and property.

To be an Association Trustee, a person must own a burial space in Nemasket Hill Cemetery either inherited or purchased and paid in full.

The Board of Trustees (hereinafter the Board) shall consist of no less than 5 Trustees. The Board shall be chosen by a simple majority vote (51%) of the Trustees present at the Annual Meeting.

Trustees shall be elected for 5 year terms and shall serve without pay.

Trustees may be removed only by a simple majority vote (51%) of the Trustees present at the Annual Meeting or Special Meeting called for that purpose.

The Board has the duty to oversee the operation of the cemetery, the Association and its financial affairs. The Board shall have the general management of the business and affairs of the Association. The Board may appoint agent or agents, as they deem necessary, to attend to the details of the business of the Association, under their instruction; and they shall have full power to describe duties and fix the compensation of such agents and remove them if deemed necessary.

A compensated person of the Association can be a non-voting Board member, provided that they have a burial space paid in full.

Article 6 Cemetery Price List

The Board may set the price of cemetery grave space and niches that remain unsold, the opening and closing of graves or niches for burial, foundations and clerical fees.

Article 7 Lots and Niches

Lots and niches become the property of the deed holder or may be passed onto family members. The lot or niche may NOT be sold privately. The Board may buy back the lot/niche for the original purchase price, less clerical fees.

The Board will establish rules that control the decorating of graves and/or niches.

Article 8 Fiscal Year

A fiscal year (also known as a financial or budget year) is a 12 month period used for calculating annual (yearly) financial statements in businesses and other organizations. The fiscal year of the Corporation shall be the period beginning April 1 and ending March 31 of the following year.

Article 9 Meetings

The Annual Meeting of the Association shall be held in Middleborough, Massachusetts in the month of April, at such time and place as the Board of Trustees may determine.

Board of Trustees Meeting is once a year, following the annual meeting. The Board shall meet and elect by simple majority (51%), the officers for the Board from the Trustees.

Regular Meetings of the Association shall take place at least once a quarter. Subcommittees may report to the Board at regular meetings. A written outline or report should be given to the recording secretary by the subcommittee, for ease of note taking.

Special Meetings of the Board may be held at the request of at least 3 Trustees of the Board or at the discretion of the President.

Article 10 Voting

Each Trustee has ONE vote. Absentee votes are only allowed if the Board agrees in advance of the voting date. If the Board approves, an absent Trustee must submit his/her vote in writing prior to the meeting. A proxy vote will not be counted.

Article 11 Officers

The officers of the Corporation/Association shall consist of president, vice-president, secretary and/or clerk and treasurer.

The officers will be chosen from the Board of Trustees by a simple majority vote (51%) at the Board meeting following the annual meeting.

The officers will hold their offices for a term of one year, or until their successors are chosen. However, an officer may serve more than one year, if re-elected by the Board.

- A. The president shall be responsible for calling to order meetings. This includes naming a time and place of all such meetings which shall be communicated to all Trustees. The president shall be responsible for making the agenda for any meeting except Special Meetings as the ONLY business transacted at a special meeting shall be the specific purpose for which the meeting was called. The president shall be entitled to vote at all meetings.
- B. The vice-president shall share equally the duties of the president. In addition, the vice-president will conduct meetings in the president's absence.
- C. There shall be at least 2 Trustee signers on each financial account.
- D. Notices of annual meetings shall be published by the secretary in a publicly accessible media, at least 7 days before the time of holding said meeting. The notice shall state the time, place and purpose of the annual meeting. The secretary and/or clerk may need to obtain permission for location. The secretary and/or clerk shall notify Trustees of any Special Meetings requested by the president.
 - The secretary and/or clerk will take attendance at each meeting. The secretary and/or clerk shall record the minutes of the Board and submit the same to each Trustee at the next meeting. All minutes from the previous meeting must be approved or disapproved at the subsequent meeting. The secretary and/or clerk will keep all recorded and approved minutes of meetings in a binder of all previous meetings for reference purposes. If the secretary and/or clerk is unable to attend a meeting, the office may be filled pro tempore for that meeting by the treasurer.

The secretary and/or clerk will keep all correspondences in a binder for reference purposes.

The secretary and/or clerk shall issue a contract for any client wishing to purchase a lot/niche. The secretary and/or clerk/treasurer will record all deeds of burial lots and niches in books kept for that purpose, when it has been paid for in full. The lot owner will receive a deed, with the Association seal, when paid in full. The secretary and/or clerk will enclose the up-to-date cemetery rules with the deed.

The secretary and/or clerk will file the state annual report with the secretary of state by November 1 of each year. The report will list the current Trustees, officers and their current addresses.

E. The treasurer will be a co-signer on all financial accounts. There shall be at least 2 Trustee signers on each financial account.

The treasurer shall keep and/or oversee the keeping of financial records of the Corporation/Association. The treasurer will insure that all monies received and all monies paid out are properly recorded. The treasurer will report to the Board the financial status of the Association on at least a quarterly basis. The treasurer will file all state and federal tax forms.

The treasurer/secretary and/or clerk shall sign all deeds of lots/niches when paid in full.

The treasurer will perform such duties as directed by the Board.

The treasurer will keep track of clients with payment plans, that are due the fifteenth of each month.

The Board will impose dollar limits over which the treasurer will not spend on any item without the specific approval of the Board.

F. On the retirement from office, each officer shall turn over all books, records, papers and other property of the Association to the succeeding officer within 30 days of retirement of office.

Article 12 Seal

The seal of the Association is circular with the name of the Association and the year of its incorporation engraved upon the face so that the same may be impressed upon paper.

The seal will be on each deed to be sent to a lot/niche owner when payment is made in full.

Article 13 Perpetual Care Funds

Perpetual Care funds are held by the Treasurer for town of Middleborough in an irrevocable trust.

Appendix

These Bylaws were created with Chapter 114 Massachusetts law referenced.

The original Bylaws of 1886 were referenced.

Footnotes

- 1. As of 2014, the town has locked funds into an interest bearing account for a period of 5 years. The amount at the time of investment was \$80,000.
- 2. Nemasket Hill Cemetery Association is only allowed to withdraw accrued interest for general cemetery purposes from the Perpetual Care Funds.
- 3. As prescribed by the will of **Edgar Paun**, each spring prior to Memorial Day, the Association will maintain (rake, clean-up, set flowers) the Paun lot, located at the corner of Central & Walnut Avenues.

4. Community Preservation Commission Grant Contract-for the iron arch and gates Article #5

The Recipient, hereafter referred to as NHCA (Nemasket Hill Cemetery Association) shall maintain the restoration of the iron arch and/or iron gates, which are the subject of this Grant Agreement, in good condition for a period of ten(10) years from January 20, 2018, the date the NHCA signed the Grant Agreement. If NHCA fails to maintain the improvements of the iron arch and/or iron gates in good condition during the ten-year period ending January 20. 2028, and such failure persists for a period of six (6) months after written notice from the Town to the NHCA of such failure, the NHCA shall pay to the Town a sum of money equal to the amount of the grant funds (\$12,600 for the iron arch) and/or (\$8,600 for the iron gates) paid by the Town under this Grant Agreement within seven (7)months after the date of said written notice of failure by the Town to NHCA. The Town may take all reasonable and necessary action to recover said sum of money including a legal action against the NHCA. Annually the Trustees will inspect the iron arch and gates for any signs of rust, weather permitting, prior to the annual spring meeting, so, it will be discussed and documented in meeting notes. If any spots are discovered, the Trustees will call Cassidy Bros. Forge, Inc.. During the ten year time frame, Cassidy Bros. Forge, Inc. (of 282 U.S. Route 1, Rowley, MA, phone number 978-948-7303) will conduct 5 year incremental inspections beginning May of 2023. They have requested a reminder when inspections are due. Request from Vin Cassidy)

5. Community Preservation Commission Grant Contract-for the iron arch and gates Article #9

The Recipient, hereafter referred to as NHCA (Nemasket Hill Cemetery Association) is required to maintain and preserve the restored iron arch and/or iron gates, in accordance with the Secretary of the Interiors Standards for Historic Preservation for a period of no less than twenty(20) years from the date of the project's completion May 17, 2018. During this time period, any proposed changes to the structures (iron arch and/or iron gates) must be reviewed and approved by the CPC(Community Preservation Commission), which may also delegate oversight responsibilities for these historic structures (iron arch and/or iron gates) to the Middleborough Historic Commission. If the

NHCA fails to maintain the historic character of these structures (iron arch and/or iron gates) during the twenty(20) year period (May 17, 2038), and such failure persists for a period of six(6) months after written notice from the Town to the NHCA of such failure, the NHCA shall pay to the Town a sum of money equal to the amount of grant funds (\$12,600 for the iron arch) and/or (\$8,600 for the iron gates) paid by the Town under this Grant Agreement within seven(7) months after the date of said written notice of failure by the Town to the NHCA. The Town may take all reasonable and necessary action to recover said sum of money including bringing legal action against the NHCA. Annually the Trustees will inspect the iron arch and gates for any signs of rust, weather permitting, prior to the annual spring meeting, so, it will be discussed and documented in meeting notes. Typical coverage to remove medium deposits will vary from 250 to 350 square feet per gallon of D2. I tend to go with the lower amount when I am applying. From your measurements and including a roof I have estimated 2866 square feet. I would round off to 3000 sf. Divide by 250 and I arrive at 12 gallons.

You might want to add a few more gallons just to be safe.




